SCHEDULING ORDER NO. 1

On August 19, 2019, in accordance with Fed. R. Civ. P. 16, Chief United States District Judge Julie A. Robinson and United States Magistrate Judge Teresa J. James conducted a scheduling conference in this case. Consistent with the Court's July 31, 2019 Order Appointing Counsel in this multidistrict litigation ("MDL"), Plaintiffs appeared through Co-Lead and Interim Class Counsel Rachel E. Schwartz, Gary E. Mason, Michael R. Reese, and Scott A. Kamber. Defendants appeared through Lead Counsel Richard B. Goetz and Liaison Counsel Thomas P. Schult. Jennifer B. Wieland also appeared on behalf of Defendants.

The parties report that they have chosen a mediator and scheduled mediation for October 29, 2019. After considering the parties' August 12, 2019 Joint Status Report² and the statements of counsel during the conference, the Court enters this Scheduling Order No. 1, summarized in the table that follows, which focuses on ensuring that the parties are prepared for an early mediation.

The parties have already submitted, and the Court has entered, an agreed Protective Order.³ If the parties agree concerning the scope and form of (1) a protocol for discovery of electronically stored information ("ESI"), and (2) a document preservation order, they shall jointly submit proposed orders by September 16, 2019.⁴ If the parties disagree concerning the

scope or terms of either order, counsel shall submit their respective proposed orders, indicating

areas of disagreement by redline and accompanied by separate supporting briefs limited to five

(5) pages setting forth their respective positions, by September 16, 2019. The submissions shall

be made by email to ksd_james_chambers@ksd.uscourts.gov.

In the joint status report to be filed by September 23, 2019, the parties are to indicate

whether the status conference set for September 26, 2019 is necessary and, if so, topics for

discussion. Additionally, if the parties agree that a conference is necessary but that a telephonic

conference would be appropriate, they may jointly request leave to appear by telephone in their

status report.

This Scheduling Order No. 1 will not be modified except by leave of Court upon a

showing of good cause.
